Terms and Conditions

By registering for ESI 2019 you are agreeing to the following terms and conditions. Please read them carefully.

- You hereby wish to make an application to participate in Enduro Student India 2019 and will be bound to follow the regulations for the competition. The regulations are subject to be updated due to various circumstances, of which you will be intimated in written via official email to your registered email id.
- The registration fees for Enduro Student India 2019 as follows

- Installment dates are fixed and cannot be postponed on request from team, however the same is subject to change by organizers due to various factors. In case of any changes, the same will be intimated to teams in advance, in written. In case any teams fail to pay within the deadline will be charged @ INR 2500 + 18% GST on and above the failed installment amount. In case a team does not pay up within 7 days of the deadline, the team will forfeit their spot in the competition and no refund will be given.
- The above mentioned registration fees will be subject to GST@18% (or as declared by the government). GST will be calculated over and above the registration fees. REGISTRATION FEES DO NOT COVER GST OR ANY OTHER APPLICABLE TAX.
- Invoice will be raised on the first day of every month on which the installment will be payable.
- The above mentioned registration fees is applicable for 30 members in a team. In case team wants to add more team member beyond 30, INR 2000/- (plus GST) will be charged per additional member after the first 30 members.
- Teams who finished in top 20 of ESI 2018 are considered as “Seeded Entries” and are exempt from the selection quiz. They can confirm their slot for ESI 2019 directly by paying the registration fees

on or before 23rd April, 2018. If a team within top 20 of ESI 2018 who wishes to participate in ESI 2019 fails to pay the registration fees within 23rd April, 2018 they will be stripped of the “Seeded Entry” status and would require to qualify for the competition by clearing the Selection Quiz. They would also be required to pay the application fees before 23rd April, 2018, failing which, the team would not be allowed to take part in the Selection Quiz. **Teams are requested to check the “Calendar” section on the website for the latest deadlines as they are subject to change.**

- Teams, who finished beyond top 20 in ESI 2018 and/or didn't participate in any event of the Enduro Student India earlier but wish to participate in ESI 2019, are required to pay the application fee on or before 23rd April, 2018 for taking part in the selection quiz. Teams will only be granted access to the selection quiz after the payment has been verified. Once a team clears the selection quiz, they need to pay the remaining amount as scheduled above towards the registration fees for ESI 2019.
- The terms and conditions mentioned will be binding to the fullest extent to all of the team members both collectively and individually.
- Enduro Student India 2019 will contain two categories of participants, Clubman and Pro. When teams register, all registration will be to the Pro category with no teams being assigned the Clubman category. Throughout the year, the Clubman teams will be decided upon the basis of submissions provided by the teams. If a team fails to meet the submission deadline as per the conditions cited below, it will be demoted to the Clubman category. In the Clubman category, during the event, the team will only be awarded half of their gained points for all events (dynamics and statics).
- A team will be classified as a Clubman team if:
 - A team misses the deadline for any particular submission by more than 7 days.
 - A team accumulates a total delay of over 21 days against submissions combined. That means, if over the course of the different submissions throughout the year, a team has been over 21 days late, it will be demoted to Clubman category.
- The organizers reserve the right to demote a team to the Clubman class on failure to meet the above mentioned criteria.
- Any delay in submissions throughout the course of the year will cause a penalty of 1 points per day per submission category except the optional ones, irrespective of the team being demoted to

Clubman or not the penalty points will be deducted from the final score of the team.

- By submitting your entry to the competition the applicant(s) agrees that ESI 2019 will be photographed & videotaped for promotional purpose of future events & applicant(s) are giving consent to be photographed during the event.
- By submitting your entry to the competition the applicant(s) agree to authorize the organizers to use pictures, videos & other engineering documents as submitted by us as part of the competition, in public seminars to spread awareness about good engineering practice & avoiding common mistakes.
- By submitting your entry to the competition the applicant(s) agree and undertake not to agitate, litigate or seek the decision of a Court of Law on any matter or question concerning or relating to the event commencing from the submission of the entry up to the conclusion of the event and the declaration or distribution of prizes.
- By submitting your entry to the competition the applicant(s) undertake that any advertisement pertaining to their participation, performance and placing in the event shall correctly state the correct and complete title of the event “Enduro Student India 2019”. Furthermore, this will be made clear to your sponsor(s).
- By submitting your entry to the competition the applicant(s) acknowledge that the organizers of Enduro Student India enjoy the sole intellectual property rights of the event including the rights of use or distribution relative to all material, including, but without being limited thereto, logos, graphics and illustrations, images, film, footage and photographs, articles, editorial content, journalistic magazines, interviews and results.
- By submitting your entry to the competition the applicant(s) shall refrain from using in any form copying, duplicating, extracting, digitizing or disassembling onto any medium, altering, selling, republishing, transmitting, distributing on or offline or directly or indirectly exploiting for commercial purposes, all or part of the tangible & intangible elements of the event.
- By submitting your entry to the competition the applicant(s) agree and undertake to abide by the rules and regulations framed for this event including the conditions precedent set out herein and all other rules and regulations, which may hereinafter be framed.
- The registration fees do not include the charges for accommodation, food & beverages and/or transportation. Accommodation, food & beverages and/or transportation is the responsibility of each participating team. Drinking water, adequate lighting, toilets and temporary pit area will be

provided by organizers of Enduro Student India.

- Secured storage area for equipment (spares, laptop bags, food items etc) for team members need to be organized by teams and will not be provided.
- A security deposit of INR 10,000/- to deposited during onsite registration as insurance against littering and damage to the facilities onsite.
- In consideration of the acceptance of this entry, the team agree to save harmless and keep indemnified the organizers of Enduro Student India 2019 , officials, the sponsors, agents, representatives, employees and all persons assisting them in this event and all owners and tenants of private property traversed by this event, from and against all actions, claims, cost, expenses and demands in respect of death, disability or injury to myself or any other person or persons or loss or damage to any property including the car concerned in this event, if any or otherwise howsoever and not withstanding that the same may have been contributed or occasioned by the negligence of the organizer and their official, agents, representatives, employees and all persons assisting them in this event or for that matter any fellow competitor(s). The indemnity shall be binding on the applicant(s) heirs, executors and legal representatives.
